Stronger Together: Supporting Farm Stewardship Through Collaboration

East Central Farm Stewardship Collaborative

- The ECFSC started in 2008. Its purpose is to facilitate the collaboration of conservation and farm organizations, increasing the number of on-farm projects through stacked funding and increased technical support.
- Early lessons learned:
 - Farm collaborations reflect regional priorities: partner organizations are already familiar with existing problems
 - There is need for strong focus on tangible action: important to make ideas come to life to incentivize new partners
 - It takes time to understand the perspectives of partners: may come from different backgrounds and experiences
 - Get roles and intentions of partners in writing: Memorandum of Understanding (MOU) or a Terms of Reference
- Past project examples: barnyard clean water diversion, wetland restoration and fencing, natural windbreaks creation

Eastern Ontario Farm Stewardship Collaborative

- The EOFSC started 2 years ago. It operates in a similar way to the ECFSC but in a different delivery area.
- Past projects include, but aren't limited to, livestock fencing, wetland restoration, riparian/grassland planting, cover crops, alternative watering sources, livestock fencing, alternative watering, nutrient management/precision farming

Benefits of farm stewardship collaboratives

- Benefits for landowners and farmers: support from experts in the field, site visits and personalized advice, technical assistance (project design, permits, and organizing volunteers), funding often from several members of collaborative
- Benefits for the collaborative: joint promotion/cross promotion advantages, joint fundraising from many sources, technical support, regionally flexible as needed, low overhead but higher impact work

Keys to success when starting a farm stewardship collaborative

- Be clear about your collaborative goals, consider the regional focus, and consider the priorities of all partners involved
- Assign coordinator(s): people to steward the collaborative and ensure every partner's needs are being met
- Outline everything in a MOU/Terms of Reference document to set the foundation for the collaborative
- Communication is key: determine who is responsible for what, who has the expertise, and who has the funding
